## What is a "Rock Drop"?

KCSA and St. Mary's Center will sell a maximum of 500 Rocks (golf balls). On Sept. 25 at Quail Chase Golf Club at approximately 1:15 PM, the rocks will be randomly placed in a bucket and dropped from the helicopter at 100 feet. The rocks will be dropped onto the driving range of Quail Chase Golf Club above a make-shift golf hole. If a rock lands and remains in the hole, the owner of the rock wins \$20,000. If no rock lands and remains in the hole, the owner of the rock closest to the pin wins \$10,000. If there are multiple grand prize winners, the winners will split the amount of the prize. Winners will be announced following the rock drop and **do not** have to be present to win. If the winner is not present they will be notified by mail or phone.
